अधिसूचित किया जाता है कि हिमाचल प्रदेश स्कूल शिक्षा बोर्ड ने अपनी 98वीं बैठक दिनांक 16.7.2011 की मद सं0 4 के अन्तर्गत निर्णय लिया है कि माननीय उच्च न्यायालय द्वारा CWP No.92/2006 में संबद्धता बारे दिये दिशा-निर्देशों के पैरा नम्बर 16 पर दिये गये निर्देशों के अनुसार निर्धारित संबद्धता विनियम के नियमों में निम्नलिखित संशोधन किये जाएँ । इसके अतिरिक्त बोर्ड ने निर्देश दिये हैं कि इस सम्बन्ध में बोर्ड अधिवक्ता से राय भी ली जाए, यदि आवश्यक हो तो मामला माननीय उच्च न्यायालय में उठाया जाये :-

That for the academic session 2007-08 commencing in April,2007 and thereafter all applications for affiliation by schools should be invited by the Board by issuing advertisements in the month of November of the year previous to the academic year for which affiliation is sought in leading newspapers being widely circulated in Himachal Pradesh (three English and three Hindi)requiring that the applications for affiliation should be submitted to the Board by 31 st December of the year prior to the year for which affiliation is sought that is to say that for the academic year 2007-08 the applications for affiliation should be submitted to the Board by 31 st December 2006 and no application for affiliation should be entertained thereafter under any circumstances.	1. That for the academic session 2012-13 commencing in January,2012 and thereafter all applications for affiliation by schools should be invited by the Board by issuing advertisements in the month of August of the year previous to the academic year for which affiliation is sought in leading newspapers being widely circulated in Himachal Pradesh (three English and three Hindi)requiring that the applications for affiliation should be submitted to the Board by 30th September of the year prior to the year for which affiliation is sought and no application for affiliation should be entertained thereafter. However, the Chairman shall have the power to decide any delay cases on merits.
2. The Board shall constitute one or more inspection teams to visit the schools. The Board may also consider associating the officers of the Education Department in the inspection team. These inspection teams shall visit the schools within one month of the submission of the application for affiliation so that the last such report is received in the Board by 31 st January of the year for which the affiliation is sought.	2. The Board shall constitute one or more inspection teams to visit the schools. The Board may also consider associating the officers of the Education Department in the inspection team. These inspection teams shall visit the schools within one month of the submission of the application for affiliation so that the last such report is received in the Board by 31st October of the year prior to the year for which affiliation is sought.
3. The Board shall convey the objections, if any, raised by the inspection team(s) to the schools(s) by registered post and courier within 15 days thereafter i.e.latest by 15 th February of the year for which the affiliation is sought	3. The Board shall convey the objections, if any, raised by the inspection team(s) to the schools(s) by registered post and courier within 20 days thereafter i.e.latest by 20th November of the year prior to the year for which affiliation is sought.

4. The School(s) may remove the objections and submit the applications after removal of objections by 28 th February of the year. The Board shall then ensure that the orders on the application for affiliation are passed on or before 31 st March of the year for which the affiliation is sought.	4. The Board shall then ensure that the orders on the application for affiliation are passed on or before 20th January of the year for which the affiliation is sought.

अधिसूचित किया जाता है कि हिमाचल प्रदेश स्कूल शिक्षा बोर्ड ने अपनी 98वीं बैठक दिनांक 16.7.2011 की मद सं० 5 के अन्तर्गत निर्णय लिया है कि माननीय उच्चतम न्यायालय नई दिल्ली द्वारा in the WPC No.483/2004 dated 13/04/2009 titled Avinash Mehrotra Vs Union of India & Ors के फैसले के अनुसार शिक्षण संस्थानों में अग्नि सुरक्षा तथा भवन सुरक्षा सम्बन्धी उपाय करना अनिवार्य है जिसके लिए मुख्य अग्नि शमन अधिकारी से अग्नि सुरक्षा का प्रमाण पत्र तथा भवन सुरक्षा के लिए अधिशाषी अभियन्ता (Executive Engineer) लोक निर्माण विभाग से भवन सुरक्षा प्रमाण पत्र संबद्धता प्रदान करने के लिए प्राप्त करना अनिवार्य है।

अतः बोर्ड ने संबद्धता रेगुलेशन के नियम 16.4.3 में निम्नलिखित प्रकार से संशोधन किये जाने का निर्णय लिया है:-

अधिसूचित किया जाता है कि हिमाचल प्रदेश स्कूल शिक्षा बोर्ड द्वारा 98वीं बोर्ड बैठक दिनांक 16.7.2011 की मद सं0 14 के अन्तर्गत विचार किया कि नियमित छात्रों के प्रवेश पत्र सम्बन्धित पाठशाला के प्रमुख के माध्यम से प्राप्त किये जाते हैं। नियमित छात्रों के प्रवेश के लिये शिक्षा विभाग/बोर्ड द्वारा कुछ नियम निर्धारित किये गये हैं जिनके आधार पर नियमित छात्रों का प्रवेश स्कूल प्रमुख द्वारा दिया जाना अपेक्षित है। छात्रों को प्रवेश देते समय ही सभी औपचारिकताओं, यथा SLC, Migration, अंको की निर्धारित प्रतिशतता, आयु आदि के बारे में आश्वस्त होने के बाद ही कक्षाओं में प्रवेश देना अनिवार्य है। अतः यह स्कूल प्रमुखों का ही दायित्व बन जाता है कि वे केवल पात्र छात्र को ही प्रवेश दें तथा उसका प्रवेश पत्र बोर्ड कार्यालय को परीक्षा के लिये भेजें। परन्तु बहुत से स्कूल प्रमुखों द्वारा अयोग्य छात्रों को प्रवेश दिया जा रहा है जिस कारण बहुत से मामलों में छात्र न्यायालय में जा रहे हैं जो कि न तो शिक्षा विभाग या बोर्ड के हित में और न ही छात्र हित में है, क्योंकि बोर्ड के पास उनके प्रवेश पत्र अक्टूबर मास में आते हैं तब तक आधा सत्र निकल चुका होता है।

इस विषय पर गहन विचार विमर्श के पश्चात बोर्ड ने निर्णय लिया है कि नियमित परीक्षार्थियों की पात्रता की बोर्ड अपने स्तर पर जांच करेगा परन्तु प्रवेश के समय पाठशाला प्रमुख द्वारा स्वीकृत किये गये प्रवेश पत्रों में पाई जाने वाली त्रुटियों के लिये सम्बन्धित पाठशाला प्रमुख ही जिम्मेवार होगा।

इस संदर्भ बोर्ड ने निर्णय लिया है कि Himachal Pradesh Board of School Education, Examination Regulations, 1994 के अध्याय 3 ADMISSION TO AFFILIATED INSTITUTIONS नियम 3.5 ADMISSION PROCEDURES में 3.5.9 निम्नलिखित नियम का निर्धारण कर लागू किया जाये।

3.5 ADMISSION PROCEDURES:-

3.5.9 The candidature/ eligibility of regular candidate shall be ensured & checked by the Principal/Headmaster/Head of the Institution of Government School/Private Schools or Institutions affiliated to the Board and the admission granted by the Principal / Headmaster / Head of the Institution of Government School/Private Schools or Institutions affiliated to the Board shall be treated as final.

Provided that checking of candidature/eligibility of such admission forms shall be done by the Board but the concerned Head of the Institution will be responsible for any discrepancy found in the candidature/eligibility of the regular candidates .

4.9 WHO CAN BE A PRIVATE CANDIDATE FOR THE MATRICULATION EXAMINATION.

4.9.7 Candidates who have already passed Oriental Title or a Modern Indian Language Examination from the Punjab University/Himachal Pradesh University may appear in English only. Such candidates having passed the examination in English only shall be exempted from appearing in English when they appear in the remaining subject to qualify the Matriculation Examination, but they shall not be eligible for scholarship.

4.9.8 Candidates who have passed the Proficiency/High Proficiency of honours examination in Sanskrit or Hindi or Urdu from Punjab University /H.P. University shall if he/she so desires, be exempted from passing in that language. In awarding marks for this language, pass marks shall be taken as representing the value of those marks.

4.9.9 Students who passed Higher Secondary Core Examination before 1965 are allowed to qualify in English and Mathematics of X Class Examination as Private candidates.

4.9.10 A candidate who has passed Matriculation Examination from another recognised University/Board without English be allowed to take up English only Examination of X class.

4.9.11 The following candidates may appear as private candidate in Matriculation examination if they have passed the Middle Standard Examination of the Board or an equivalent examination from a recognized Board/University/ Institution at least *two* years earlier than the year in which they *would* take Matriculation Examination;

(a) All persons who are bonafide residents of Himachal Pradesh;

(b) A candidate who has passed the Middle Standard examination from this Board;

(c) Members of regular Land, Air and Naval Forces serving in Himachal Pradesh or their wards;

(d) Members of Border Police serving in the State of Himachal Pradesh or their wards;

(e) Members of any security force created by the Ministry of Home Affairs, serving in Himachal Pradesh or their wards;

(f) All persons who are residing in Himachal Pradesh for nine months preceding the commencement of Examination.

Provided that in respect of category (c), (d) and (e), a certificate from the Commanding Officer of the Unit, in case of category f), a certificate from

the employer along with a solemn declaration duly attested by the Executive Magistrate First Class to the effect that the candidate is residing in Himachal Pradesh for nine months preceding the commencement of examination, shall be appended with the admission form.
